- 3. Oral report with abstracts publication (up to 10 minutes, will be agreed with the secretariat of the Organizing Committee and depends on the Conference format).

Conference languages: Ukrainian, English.

#### SUBMISSION OF MATERIALS FOR PARTICIPATION IN THE CONFERENCE:

To take part in the Conference participant before <u>August 25, 2021</u> have to fill in <u>electronic application form</u> with the obligatory attachment of abstracts in the .docx format. The results of registration and materials submission can be tracked by <u>link</u>.

#### **REQUIREMENTS FOR MATERIALS:**

### 1. Requirements for abstracts:

- abstracts have to be sent in the format MS Word .docx;
- volume up to 3 pages (A4):
- margins top 2 cm, bottom 2 cm; on the left 2 cm; on the right 2 cm;
- font Times New Roman; size 14; interval multiplier 1,15;
- the title of the work is given in **bold**, **capital letters**; the next line indicates **the name of the author (authors)**; on the next line **the full name of the institution, city, country**; below **e-mail of the author** for correspondence;
  - scientific titles and scientific degrees of the authors are not indicated;
- the supervisor cannot be both a co-author and a supervisor of the submitted abstracts;
  - **obligatory structure of abstracts:** introduction, purpose of research, materials and

methods, obtained results and conclusions. Abbreviations of words and terms in the title are not allowed. References are not provided. The abstracts uses a system of SI units. The abbreviation is deciphered after the first mention in the text and remains unchanged throughout the work;

- dots should be used in decimal fractions (for example: 0.1 or 0.358). The symbols "<", ">", "%", " $\pm$ " are written without separation from the previous ones: for example, p<0.95, t>37°C, 16%, 0.23 $\pm$ 0.01. In the text of abstracts one does not need to use bold, italics and other design techniques;
- when using the results of statistical data analysis, it is obligatory to indicate the software and its version, also on have to indicate the methods of statistical processing, the level of probability when testing statistical hypotheses and calculate the confidence interval for the main results of the study;
  - the use of tables, graphs, charts and illustrations is allowed.
  - **file name**: section number\_Surname N. (for example, 1\_Petrenko A.G.);.

## 2. Requirements for poster presentation:

- the title of the work is indicated in the upper part of the poster (in capital letters, bold, no more than three lines), on the next line the surname and name of the authors (not in bold, scientific degrees are not indicated); below full name of the institution, city, country; on the next line e-mail of the author for correspondence;
- the name of the section is indicated (not in bold) in the upper right corner (above the name);
- poster should contain the results of scientific investigation: the aim of the study, materials and methods, the results of research in the form of graphs, tables, diagrams, illustrations, diagrams, drawings (the size of which should not exceed A4) and conclusions;
  - poster size: A1 (594x841);
  - the size of the font used should allow reading from a distance of 100 cm.

Abstracts that do not meet the specified requirements in the design, submitted in violation of the deadlines will be returned to the authors for adjustments. Corrected abstracts must be returned no later than one week after submission to the authors.

Abstracts that have not been corrected will not be considered.
